

## **MOUSSEAL®-ATC F-0** #2045 FOAM EXTINGUISHING AGENT FOR EXTINGUISHERS



### **Description**

*MOUSSEAL®-ATC F-0* is a ready-touse alcohol resistant liquid fire extinguishing agent based special surfaceand interface-active surfactants with polymers. Its fire performance complies with the highest standards.

#### **Properties**

*MOUSSEAL®-ATC F-0* contains a special combination of salts and surfactants, which wets and impregnates the surface of class A fires most effectively, thus enhancing the fire resistance of the fuel.

*MOUSSEAL®-ATC F-0* forms an aqueous film on non-polar hydrocarbons, creating a lasting, gastight cover over the flammable area.

#### **Application**

*MOUSSEAL®-ATC F-0* is used undiluted with portable extinguishers and sprinkler systems to extinguish fires of solid materials (class A) and of nonpolar liquid fires (class B) according to DIN EN 3 as well as polar liquid fires.

### Environment

None of the raw materials used in our products are banned. Our foam concentrates comply with the latest environmental regulations, such as 'Commission Regulation (EU) No 757/2010', amending '(EC) No 850/2004.' *MOUSSEAL®-ATC F-O* will also comply with the 'significant new use rule (SNUR)' for long-chain perfluoroalkyl carboxylate proposed by the Environmental Protection Agency, which will come into effect in due course.

#### *Compatibility with other foam concentrates* Mixing for immediate use:

*MOUSSEAL®-ATC F-0* can be mixed for immediate usage with other equivalent foaming agents, independent of the mixing ratio. When *MOUSSEAL®-ATC F-0* is to be added to existing stocks of foaming agents we recommend to have the quality of the available stock tested by our laboratory.

*MOUSSEAL®-ATC F-0* stocks must not be mixed with other products.

Mixing for long term storage:

Prior to replenishment, the quality of *MOUSSEAL®-ATC F-0* stocks should be examined by our laboratory.

Blending of *MOUSSEAL®-ATC F-0* with other foam concentrates for long-term storage is not recommended unless tested and approved by our laboratory.

Mixing with synthetic concentrates:

*MOUSSEAL®-ATC F-0* must not be mixed with synthetic detergent, alcohol resistant, or protein foam concentrates.

Mixing with other expanded foams:

*MOUSSEAL®-ATC F-0* foams are compatible with all other readily expanded fire extinguishing foams.

### Compatibility with powder

*MOUSSEAL®-ATC F-0* is suitable for the combined use with foam compatible dry chemical powders.

#### **Packaging**

*MOUSSEAL®-ATC F-0* is available in plastic cans, plastic drums, IBC's (totes) and in bulk.

#### Storage

*MOUSSEAL®-ATC F-0* can be stored for long periods of time in the sealed original containers and in corrosionresistant plastic or stainless steel tanks. High temperatures up to +50°C do not affect the quality, neither does temporary freezing at temperatures below the specified frost resistance limit.

### Shelf Life

*MOUSSEAL®-ATC F-0* has a shelf life of >10 years, if stored according to our recommendations (see technical info leaflet TM014 'Storage of Synthetic Fire Extinguishing Foam Concentrates').
